What information will Jemstone UK Events collect about you?

Enquiries

Where it is appropriate we may also ask for:

How Jemstone UK Events will use the information we collect about you

We will mainly use your personal information to:

- Administer your booking/enquiry
- Support your requirements
- Keep a record of your relationship with us
- Ensure we know when we can contact you
- Understand how we can improve our services, products or information.

Cookie policy

If you enter your details onto one of our online forms, and you don't 'send' or 'submit' the form, we may contact you to see if we can help with any problems you may be experiencing with the form or our websites.

Jemstone UK Events also uses cookies. Cookies are small text files on your device. They are made by your web browser when you visit a website. Every time you go back to that website, your browser will send the cookie file back to the website's server. They improve your experience of using a website, for example, by remembering your preference settings and by measuring your use of a website to ensure that it meets your needs.

We may also use your personal information to detect and reduce fraud and credit risk.

We might use your personal information:

So that we can understand our clients better

Build profiles and target communications to similar clients.

We use generic profiling and screening techniques to ensure communications are relevant and timely, and to provide an improved experience for our clients.

When building a profile we may analyse geographic, demographic and other information relating to you in order to better understand your interests and preferences in order to contact you with the most relevant communications.

To keep you informed and ask for additional support

Jemstone UK Events will not, under any circumstances, share or sell your personal data with any third party for marketing purposes and you will not receive offers from other companies or organisations as a result of giving your details to us.

We ensure that there are appropriate technical controls in place to protect your personal information.

We undertake regular reviews of who has access to personal information that we hold to ensure that your personal information is only accessible by those who have a need to access it.

We use external agencies, such as, email and SMS broadcasters to collect or process personal data on our behalf. Such agencies can only act in accordance with our instructions. We do comprehensive checks on these agencies before we work with them, and put a contract in place that sets out our expectations and requirements; especially regarding how they manage the personal information they have collect or have access to.

Content provided by you

Where you contribute material to us, e.g. user generated content or in response to a particular marketing campaign or event we will generally only keep your content for as long as is reasonably required for the purpose(s) for which it was submitted unless otherwise stated at the point of generation.

Your choices and rights to know what we know about you, make changes or ask us to stop using your data

Under the Data Protection Act you have the right to request a copy of the personal information we hold about you and to have any inaccuracies corrected. We do not accept these requests by email so we can ensure that we only provide personal information to the right person.
